This Memorandum of Understanding (MOU) is drawn up and agreed upon to establish the cooperation between Chhatrapati Shivaji Kala Mahavidyalaya, Asegaon Purna, Dist Amravati M.S. 444807 and Shri Shivaji College of Horticulture, Amravati, Maharashtra, 444602.

### CHHATRAPATI SHIVAJI KALA MAHAVIDYALAYA, ASEGAON PURNA:

College has been established and run by Veer Bajirao Kasahe or Vyayam Mandal. Before one of the premiere educational institute in Chandur Bazar Taluk. Chhatrapati Shivaji Kala Mahavidyalaya has been established in 13th June 2009 at Asegaon purna. Chandur Bazar Tehsil of Amravati District in Maharashtra State. The college is located at Asegaon purna, which is 30 km away from Amravati District. The college campus having 5 acres of land in which 2 acres for playground. This is the only senior college of Veer Baji Pratin Kasahe or Vyayam Mandal with Arts faculty. The college is Grant-in-aid college and permanently affiliated to Sant Gadge Baba Amravati University, Amravati and also got 2F & 12B affiliation from the U.G.C. in 2014. The college is aiming to educate youth, woman & members from weaker sections in Asegaon purna and surrounding rural area. We are making efforts to attain these motives by improving our own standards. At present 350 to 400 students are in the flow of higher education. These students are being trained in academic, co-curricular, extra curricular, extension programmes and sport activities.

### **ARTICLE II: RATIONALE**

This joint venture between Chhatrapati Shivaji Kala Mahavidyalaya, Asegaon Purna and Shri Shivaji college of Horticulture, Amravati will promote cooperation among these institutions and their students by paving unique collaboration for Agricultural education, research, and extension activities.

It will prepare trained batches of future professionals for quality education in dedicated fields. This collaboration will focus on emerging areas to attract exclusive class of motivated students and this cooperation will lead to quality education with an international exposure.

### **ARTICLE III: BOARD OF STUDIES, COURSE MENTORING, FACULTY AND STUDENTS EXCHANGE**

- 1 **Board of Studies:** The Board of Studies is a statutory body and reports to the Academic Council through the Dean Concerned. All academic matters like Introduction of a new Academic Programme, Revision of course syllabus and scheme, evaluation of research work, review of academic rules, etc. shall be handled by the board of studies in collaboration with both Chhatrapati Shivaji Kala Mahavidyalaya, Asegaon Purna and Shri Shivaji College Of Horticulture, Amravati.
- 2 **Course Mentoring:** Your institute stands to benefit immensely from the vast expertise of the Shri Shivaji College of Horticulture, Amravati which it has built upon through years of hard work and an unparalleled dedication to knowledge dissipation. Shri Shivaji College of Horticulture, Amravati can thus help your institute in designing the curriculum for courses in which Shri Shivaji college of

Horticulture, Amravati has significant expertise. Course Mentoring would typically involve experts from the faculty, Shri Shivaji College of Horticulture, Amravati helping and mentoring the faculty of your institute in designing curriculum and guiding them with innovative pedagogical approaches. One or two courses per semester can be narrowed down for the same through mutual agreement.

- 3 **Faculty Exchange:** There will be exchange of faculty for delivering lecture on various topics. Exchange in terms of information on teaching, learning material and other literature relevant to their educational and research programs in particular area of expertise.
  
- 5 **Student Exchange (Short term) for Under Graduate programmes:** Student Exchanges lasting for 12 working days can take place once in each year. Such exchanges can take the form of field projects/practical sessions/Hands on with the students getting the additional benefit of interacting with their peers and learning with them.

#### **ARTICLE IV: SPECIAL PROVISION**

- Both institutions will consult each other and resolve informally disputes or misunderstandings that arise in the administration of this MoU.
- Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's official/faculty members, and the logos for the activities under this MoU, and dissemination of results, on a case-by-case basis.

#### **ARTICLE V: DURATION, TERMINATION, AND AMENDMENT**

- This MoU will be effective from the date of signing by both parties and will be valid for 5 years. It may be subject to extensions by mutual consent in writing.
- Either party may terminate this MoU by giving six (06) months advance notice in writing

- The provision of this MoU may be amended at any time, with mutual consent in writing. In particular both parties shall review the progress of the program every 03 years and make necessary revisions in the MoU, if required, with mutual consent in writing
- The amendment, termination and expiration of this MoU will not affect the terms and activities ongoing at the time of notification of amendment, termination, and expiration unless otherwise agreed between the parties in writing.
